# THE ROLE

The CBBC is now looking to appoint a Chief Executive who will lead the executive team, working closely with our board, to develop and implement a strategy to grow the organisation and continue to be impactful on behalf of our members.

#### **KEY RESPONSIBILITIES**

#### Leadership

- Leading the CBBC, setting out a vision and implementing a strategy that delivers for members and maximizes our impact on behalf of members;
- Deliver financial and operating KPIs as agreed with the board, such as increasing levels of member satisfaction;
- Shape CBBC's position on current economic, commercial and political issues, lead CBBC's policy formulation process;
- Build and lead a strong leadership team in the UK and China, while ensuring effective development of colleagues throughout the organisation;
- Build a diverse. Inclusive, and values-based organisation;

#### **Stakeholder Management**

- Communicate CBBC's positions and policies to all stakeholder groups. The Chief Executive will be a visible and available spokesperson for China-Britain business interests in business and government fora and with the media in both the UK and China;
- Navigate complexity and ambiguity, coupled with exceptional relationship building skills and an established, relevant network;
- Recruit, retain and interact with a range CBBC members (e.g. from PLCs to SMEs);
- Promote CBBC's mission, programs, products and services to relevant stakeholders;

#### **Commercial Activities**

- Develop successful business service offerings to members and non-members, overseeing the design, promotion, delivery and quality of such services;
- Build scale of existing portfolio of commercial services, including China entry support, research projects, conferences, delegation hosting, IP protection support and more;
- Develop and profitably grow new China related business services to members and nonmembers;

#### **Operations & Governance**

- Develop and recommend a yearly budget that builds CBBC's long term stability. The Chief Executive is responsible for delivering the budget's financial targets and will formulate policies and action programmes for approval by the board;
- Identify and mitigate key strategic risks facing the organisation and ensure CBBC fulfils its obligations; and
- Build a strong and trusted relationship with the Chair and the board, providing advice and ensuring the board has timely access to relevant information.

# PERSON SPECIFICATION

The Chief Executive will engage extensively with Chinese and UK government officials and the business community at the highest levels. Candidates must have significant work experience in China and have sufficient credibility to build relationships at this level and be used to interfacing with senior leaders.

The Chief Executive must demonstrate experience of leading a commercially driven team. CBBC generates its revenue from membership and from multiple services provided to members and non-members. For CBBC to be successful, this must be developed on a sustainable basis.

The Chief Executive should have experience of developing their leadership team and ensuring it is equipped with the right skills and experience to grow the organisation.

The Chief Executive will take the lead in engaging with the media, communicating CBBC's policy positions and appearing regularly at conferences, events and other public fora. Candidates will therefore need to be comfortable acting as an ambassador for the organisation and be able to establish rapport quickly across a wide range of audiences.

The Chief Executive is responsible for building and maintaining a strong relationship across the range of CBBC's members, from global multinationals to small and medium sized enterprises, ensuring that CBBC provides value to all its members. Candidates must demonstrate excellent stakeholder engagement and capability to manage member diversity.

Demonstrate a strong grasp of relevant public policy and economic issues and how they impact members. Show knowledge at a detailed technical level, backed up by experience gained from meeting with business and government leaders and staff.

The Chief Executive must possess the verbal and written communication skills to influence, inform and constructively educate key UK stakeholders in the UK China relationship, especially those in government positions and those supporting them.

This role is based in London with some international travel to China.

This is a senior role and compensation will be commensurate with the experience of the appointed candidate.
