

## **About Us**

In 1596 the Archbishop of Canterbury, John Whitgift, laid the first two foundation stones of the Hospital of The Holy Trinity. A few years later, just yards down the road, he opened a school. Together, these two buildings would help him realise his founding vision to educate and care for the people of Croydon. Today, more than 420 years later, his legacy lives on.

As one of the largest bursary providers in the country, we grant thousands of young people access to an outstanding education at our Foundation schools — Trinity, and Whitgift. Through Whitgift Care, our care homes and services give older people a true sense of community, comfort, and joy in later life. And through our Carer Support Centre, we offer Croydon's carers a valuable support network — providing advice, information, and a welcome break from the isolation and exhaustion they can

endure as they care for others in our community.

We support people of all ages and backgrounds. More importantly, we aspire to bring them all together for the benefit of all – inspiring a sense of community in all that we do. Because while much has changed since 1596, the values John Whitgift stood for then are as relevant today as they ever were; perhaps even more so.

The Foundation employs over 850 people and has an annual expenditure of £83M. It has an endowment invested mainly in financial assets of around £165M.

Income from the endowment funds the Foundation's charitable activities and bursaries to allow pupils of limited means to attend its excellent schools. The remainder of its assets are commercial, residential and land assets in and around the town centre of Croydon.



# **Role Purpose**

Job title: Chair of John Whitgift Foundation

**Location:** Whitgift Almshouses, George Street, Croydon

Time commitment: Variable 1-2 days a month

### Summary of role

The chair of John Whitgift Foundation is responsible for enabling the Court of Governors to deliver the Foundation's charitable objects to educate and care for the people of Croydon. The chair supports building effective partnerships between governors, sub-committees and executive officers.

The CEO is the visible leader of the Foundation and is responsible for building effective partnerships between the Foundation's schools, care operations, key stakeholders and the local Croydon community.

Together the Chair and CEO will ensure that the Foundation is delivering its charitable objectives to the highest standards.







# **Key Responsibilities**

#### **Key responsibilities**

### **Strategy and Governance**

- To chair the Court of governors and ensure the Foundation's strategy impacts positively on the lives of beneficiaries
- To work with other governors, heads and executive officers to develop the strategy and vision of the Foundation and support its implementation through effective forward planning of agendas and committee meetings
- To support and develop governors in exercising their functions, ensuring the workload is shared and individual skills are well used
- To chair Court meetings and attend sub-committee meetings as required
- To support the Chief Executive with the recruitment, induction, appraisal and succession planning of governors to ensure there is a suitably skilled body of trustees
- To support the effectiveness of the governing body by conducting governor appraisals
- To chair the Remuneration Committee
- To support and hold the Chief Executive to account in the delivery of their duties
- To meet with Foundation staff, schools, care residents and the local community as required and ensure the views of beneficiaries are heard

### **Ensuring the effectiveness of the Foundation**

 To gain assurance through regular reporting, professional advice and effective risk management that regulatory and statutory requirements are met and pupils and residents are safe, including regular reporting to the Charity Commission

- To support the necessary decisions to ensure the Foundation is financially sustainable, financial controls are in place and that accurate annual accounts are submitted to the Charity Commission
- To maintain absolute confidentiality in respect of sensitive/commercial/personal information about the Foundation, its staff, parents, pupils and residents
- To sign and seal key documents and liaise with external stakeholders on the Foundation's behalf
- To declare any conflicts of interest and complete any required training.
- To visit and experience the Foundation's schools, Carers Information Service and care homes to maintain contact with beneficiaries

John Whitgift Foundation is committed to safeguarding and promoting the welfare of children and adults in its care and expects all governors to share this commitment.

- Likely to be an existing Chair or Non-Executive Director who is a person of stature, unquestioned integrity and independence of mind with substantial experience of both commercial and not-for-profit high profile organisations.
- Extensive experience chairing diverse Boards with an appropriate combination of empathy and authority and an ability to marshal information.
- Demonstrable interest in our strategy and ethos and a strong personal commitment to helping the Foundation achieve this.
- Commercial skills and understanding of regeneration schemes

- Resilient and diplomatic with the ability to build effective working relationships with a range of internal and external stakeholders.
- A commitment to the values of the Foundation as a Christian

- organisation that serves those of all faiths and none, and its charitable objectives to educate and care for the people of Croydon.

- Astute and confident someone whose advice is valued and sought out.

# The Commitment

The appointment is unremunerated and is for an initial term of three years and can be extended for a further two terms.

- 4 evening Court meetings per annum in person.
- Regular contact with the CEO and Sub Committee Chairs and occasional committee attendance
- Attendance at key events including the annual Founders Day in March;
   Resident Garden Parties and Open Days.

The Chair should be prepared to devote between one to two days per month to the Foundation's business and be within easy reach of London.

#### **Process**

The recruitment panel is led by Asif Patel with the Nominations and Governance Committee. Shortlisted candidates will have the opportunity to meet with the outgoing Chair and CEO in advance of interviews, which will be held in person at the Foundation's offices in Croydon.

Appointment will be followed by the completion of a DBS check.


### Due diligence
