# Welcome

Thank you for your interest in becoming a Devolved Administration Board Member of the Professional Standards Authority (PSA). We are currently recruiting for a Board Member from Wales/Cymru.

The PSA is an independent organisation, overseeing the ten statutory regulators for 1.9 million health and social care professionals, and accrediting voluntary registers of over 120,000 health and care workers.

Our work includes:

- Robust statutory powers we can refer fitness to practise decisions by the regulators to the High Court if we think they are insufficient to protect the public
- The publication of reports on the performance of the regulators and critical incident reviews of regulatory failures
- Commissioning and publishing research into the effectiveness of regulation
- Working with governments on the reform of professional regulation in health and social care.

We are looking for individuals with highly developed influencing and leadership skills to work in the interests of all members of our diverse society – we do not have preconceptions about where our new Board Member will come from, apart from living and working in Wales/Cymru, so please don't rule yourself out before reading further.

This is a unique and influential role in the high-profile field of health and social care and our new Devolved Administration Board Member will join the PSA at an interesting time with the implementation of regulatory reform. You will be part of a team working with the governments and administrations across the United Kingdom, with the statutory regulators and non-statutory registers we oversee, with representatives of highly diverse patient and professional groups, and with other stakeholders.

The Board and the Chief Executive lead a small, high-calibre organisation with staff who are widely respected in their fields. The PSA's Board Members have a broad range of senior experience, and we are now seeking a new Devolved Administration Board Member for Wales/Cymru.

# Background

The Professional Standards Authority for Health and Social Care (the PSA) promotes the health, safety and wellbeing of patients and the public by raising standards of regulation and registration of people working in health and care. We are an independent body, accountable to the UK Parliament, and work closely with the devolved administrations in Northern Ireland, Scotland and Wales/Cymru.

We oversee the work of ten statutory bodies that regulate health professionals in the UK and social workers in England. We review the regulators' performance, and audit and scrutinise their decisions about whether people on their registers are fit to practise.

We also set standards for organisations holding voluntary registers for people in health and care occupations and accredit those organisations that meet our standards.

To encourage improvement, we share knowledge and good practice, conduct research and introduce new ideas including our concept of right-touch regulation. We monitor policy developments in the UK and internationally and provide advice to governments and others on matters relating to people working in health and care.

We are committed to integrity, transparency, respect, fairness and teamwork.

## How we work

Our Board sets our strategy and monitors our performance. The Chief Executive leads our work. He and our staff are independent of government.

Our staff (about 40 people) have various skills and roles including legal, governance, conducting reviews and audits, policy, research and operations and finance.

We have three directorates: Regulation and Accreditation (overseeing regulators and Accredited Registers and how well they work), Policy and Communications (developing standards, influencing regulatory policy), Corporate Services (managing how we deliver our services).

## How we are funded

Our annual budget is around £5.1 million. We are funded in three ways:

- 1. The ten regulators we oversee pay a fee to us each year. The Health and Social Care Act 2012 provided for the PSA to be funded in the main by the regulatory bodies.
- 2. Accredited Registers apply to be accredited and pay us a fee to assess whether they meet our standards.
- 3. The Department of Health and Social Care and other bodies in the UK and internationally, commission us to provide them with advice or carry out reviews.

## Who oversees us

Parliament oversees our work. The Privy Council consults on the budget that we say we need to do our work and sets the fees that the regulators must pay. The Health and Social Care Select Committee can call us to appear and give an account of our work.

# **Our legal authority**

We were set up under the NHS Reform and Health Care Professions Act 2002. Our legislation has been amended since then. The most recent legislation was the Health and Social Care Act (2012), which gave us two new responsibilities relating to our work with Accredited Registers; and our work advising the Privy Council about appointments to the nine regulators' Councils (we do not oversee appointments to the Board of Social work England). We have the authority to:

- Review decisions made by the ten regulators about practitioners' 'fitness to practise'. We have a power to appeal decisions to the High Court (Court of Session in Scotland) if we consider them to be insufficient for the protection of the public.
- Accredit voluntary registers that meet our standards and suspend accreditation, apply conditions and remove accreditation.

We do not have the power to investigate complaints about the regulators as this part of the legislation has not been put into practice, but we do value hearing from people who are willing to share their experiences with us to help inform our work.

### **Our Vision**

Safer care for all through high standards of conduct and competence in health and social care professionals.

### **Our Mission**

To protect patients, service users and the public by improving the regulation and registration of health and social care professionals.

### **Our Values**

Our values describe how we work with colleagues and external stakeholders. We strive to promote, develop and demonstrate these values in everything we do. A positive culture leads to better performance and better outcomes for patients and the public.

Our values are:

- Integrity we will be open, honest and trust each other
- Transparency we will be clear about our performance and the reasons for our decisions with all stakeholders
- Respect we will treat each other, and those we work with outside the organisation, with respect at all times
- Fairness we will strive to be fair in all our decision-making
- Teamwork we will work in partnership to deliver better outcomes for patients and the public.

## **Our approach**

The PSA was established in 2003 and recognises the improvements made in regulation and registration since that time. The PSA continues to review and improve its core processes to reflect these improvements and to respond to our operating environment.

We introduced a new accredited registers programme in 2021/22 which is financially sustainable, cost effective, robust and better meets the needs of employers, patients and the public. We have also made changes to our performance review processes to ensure that reviews are more timely, proportionate and effective in bringing about improvements in regulation.

We will focus more on how we can use the unique role of the PSA to promote and support improvements in regulation and registration for the benefit of patients and the wider public. This will include promoting, shaping and supporting regulatory reform, recognising our key role during a period of significant change over the next few years.



### Strategic aim 1

To protect the public by delivering highly effective oversight of regulation and registration;

- To deliver our statutory duties, targeting our resources where there is greatest risk to the public
- To support high standards in health and social care regulation and registration through our performance review, section 29 reviews, accredited registers, policy and communications functions
- To review and improve our processes (including legislative changes where necessary) to ensure they are effective and efficient.

### Strategic aim 2

To make regulation and registration better and fairer;

- To lead the development of more effective regulation through reviewing our standards, and undertaking other activities including research, policy advice and quality improvement initiatives, such as sharing good practice
- To promote, influence and support regulatory reform
- To promote and monitor equality, diversity and inclusion in our work and in those we oversee.

### Strategic aim 3

To promote and support safer care for all;

- To work with others to establish the full range of functions recommended in *Safer care for all* for Health and Social Care Safety Commissioners in each of the four countries of the UK
- To work with UK governments to develop regulatory strategies to support the workforce strategies
- To work with regulators, Accredited Registers and other stakeholders to: promote positive workplace cultures; resolve any conflicts between business priorities and patient safety, and between safe spaces, accountability and the duty of candour.

# **Our Board**

The PSA's Board comprises seven non-executive members and one executive member. Specifically:

- A Chair appointed by the Privy Council
- Three non-executive members; one appointed by the Scottish Ministers, one appointed by the Welsh Ministers and the third appointed by the Department of Health, Social Services and Public Safety in Northern Ireland
- Three non-executive members appointed by the Privy Council
- One executive member appointed by our Board itself (the Chief Executive)
- An associate Board member appointed for two years.



No non-executive members of our Board may be or ever have been a member of a profession regulated by any of the ten regulators or the Accredited Registers that we oversee so that we are independent of the health and social care and allied professions.

The Board is the PSA's highest decision-making forum, where significant strategic and operational matters are discussed, and consequential decisions taken.

The PSA's Board has corporate responsibility for ensuring that it fulfils its statutory duties and for promoting the efficient and effective use of its resources.

To this end, and in pursuit of its wider corporate responsibilities, the Board:

- Sets the overall strategic direction of the PSA within statute and the policy and resources framework
- Ensures that any statutory or administrative requirements for the use of public funds are complied with; that the PSA operates within the limits of its statutory PSA, and in accordance with any other conditions relating to the use of public funds
- Ensures that the PSA receives and reviews regular financial information concerning the management of the PSA; is informed in a timely manner about any concerns about the activities of the PSA; and provides positive assurance that appropriate action has been taken on such concerns
- Demonstrates high standards of corporate governance at all times, including establishing an audit committee to help the PSA to address the key financial and other risks facing it
- Appoints the Chief Executive to the PSA and, sets performance objectives and remuneration terms linked to these objectives for the Chief Executive, which give due weight to the proper management and use of public monies.

### Committees and working groups of the Board

The Board has delegated specific duties to committees which consequently report back to the Board. These are the Audit and Risk Committee, the Scrutiny Committee and the Nominations Committee. All Board Members are expected to serve on at least one committee. All committees are advisory, although in certain circumstances the Board may delegate decisions to them.

Our Board has different skills and backgrounds. They are not health or care professionals because the legislation under which we were set up does not allow anyone who has been a member of a profession that is regulated to sit on our Board.

We welcome members of the public at our Board meetings and always invite questions.



# **Board Members**

### Caroline Corby – Chair

Caroline Corby is the Chair of the Professional Standards Authority.

Caroline attended a comprehensive school in north London. She studied for a degree in Mathematics and Statistics at Bristol University and then worked in the City for 13 years, specialising in private equity. During this period, she served as a non-executive director on around 10 private sector boards across a range of industries.

After taking a career break to raise her three daughters, Caroline joined the board of London Probation Trust in 2007 and subsequently became Chair of that organisation. Caroline's switch from the private to the public sector was motivated by a wish to do work with a greater social purpose.

Since 2015, Caroline has undertaken a number of public appointments and she has chaired fitness to practise hearings for several of the statutory health regulators. Today, as well as her role at the PSA, Caroline is Chair of the Parole Board for England and Wales/Cymru, Chair of Peabody Trust, one of the UK's oldest and largest housing associations, and she is a non-executive director of the Security Industry Authority.

Caroline wanted to join the PSA as she is committed to public protection, particularly given the vulnerability of so many patients and service users, and she enjoys teamwork and public service.

### Alan Clamp – Chief Executive

Alan Clamp is the Chief Executive Officer (CEO) of the Professional Standards Authority.

Alan has spent all his working life in the public sector and is committed to raising standards in public services. Following a degree in Natural Sciences and a PhD in Biochemistry, Alan initially followed a career in teaching before becoming one of Her Majesty's Inspectors with Ofsted and then working on the regulation of qualifications.

Alan's first Chief Executive role was at the Human Tissue Authority between 2011 and 2015. He then moved to become the CEO of the Security Industry Authority, an independent regulator sponsored by the Home Office. Alan joined the PSA as our Chief Executive in November 2018.

In addition to his role at the PSA, Alan is a non-executive director at the Parole Board for England and Wales/Cymru and the Intellectual Property Regulation Board. He is also a Trustee of the Institute of Regulation.

With over 25 years' experience in regulation, including 13 years as a Chief Executive, Alan is passionate about good regulation and the key role it plays in public protection.

### Professor Marcus Longley – Deputy Chair and Chair of the Scrutiny Committee

Marcus was the Chair of the Cwm Taf Morgannwg University Health Board from 2017 to 2021, and before that was Vice Chair of Cardiff and Vale University Health Board from 2013 to 2017.



Marcus has also served as a Board Member for the Welsh Consumer Council, and for Consumer Focus Wales and was until August 2017 Professor of Applied Health Policy and Director of the Welsh Institute for Health and Social Care, University of South Wales. He is now Professor Emeritus. He has been an Expert Advisor to the Bevan Commission, having previously been a Member there, and is a Senior Associate at The Nuffield Trust.

Marcus was educated at the universities of Oxford, Cardiff and Bristol, and worked in the NHS from 1981 to 1995. He was elected a Fellow of the Faculty of Public Health of the Royal Colleges of Physicians in 2008.

### Candace Imison – Board Member

Candace has over thirty years' experience in UK healthcare across all parts of the health system, including undertaking health research and developing health policy. She was Director of Policy at the Nuffield Trust and Deputy Director of Policy at The King's Fund where she undertook research and published on a wide range of topics, notably workforce and the configuration of services. She worked for five years at the Department of Health undertaking work on strategy in the Strategy Unit and developing health workforce and configuration policy. Latterly, she has worked for the National Institute of Health and Care Research leading on research dissemination and knowledge mobilisation.

Candace has extensive senior management experience in the NHS, including at board level for healthcare providers, commissioners and regulators. She was director of strategy for a large acute trust, director of commissioning in a health authority, and a non-executive director for Sheffield Teaching Hospitals and Kingston Hospital Foundation Trusts (where she was also Deputy Chair).

Candace holds a Master's degree in Health Policy and Health Economics from Birmingham University and an undergraduate degree in natural sciences from the University of Cambridge.

### Ali Jarvis – Board Member

Ali Jarvis is a Board member and was appointed as the devolved member for Scotland in January 2025.

Ali went to a rural comprehensive school before gaining a Modern Languages degree at Bristol University. The first phase of her career was in the private sector where she held senior management positions in marketing, human resources and strategy for large multi-national companies focusing on organisational change management, leadership and diversity.

Keen to focus increasingly on wider public benefit and social inclusion, Ali became the first Director of Stonewall in Scotland in 2000 and then moved to a UK-wide Director role at the Commission for Racial Equality.

In 2008 she became a publicly appointed Board member of the Scottish Funding Council. She followed this with a Board role with NHS Health Scotland and also chaired the Glasgow Regional Colleges Board.



For the last 20 years, alongside her Non-Executive roles, Ali has worked as a freelance consultant and coach specialising in leadership, strategic change management and governance with organisations in the public, private and non-profit sectors. She is also an independent assessor and adviser for the Office of the Ethical Standards Commissioner in Scotland.

Her commitment to public service is founded on principles of inclusion, improvement, ethics and impact.

### Geraldine Campbell – Board Member

Geraldine has extensive experience of regulating professionals through holding nonexecutive roles with the Northern Ireland Social Care Council, The General Osteopathic Council, The General Dental Council and The Pharmaceutical Society of Ireland.

She has also been involved in the quality management of the selection, training and continuing education of doctors-in-training in Northern Ireland through a lay role with The Northern Ireland Medical Dental Training Agency (NIMDTA) before becoming a Board Member of NIMDTA, with responsibility for the employment and oversight of the education and training of doctors and dentists. Geraldine has also been involved in the fitness to practice processes for nurses, midwives and pharmacists. She is passionate about the involvement of patients and service users in regulatory decision-making, particularly those least likely to be heard but most likely to be affected by decisions.

Geraldine is an experienced non-executive board member representing the public interest across a range of public bodies since 2007, having previously been a Chief Executive in the charity sector. Earlier in her career she had roles in patient public involvement, consumer services and complaints management for a Health and Social Care Commissioning body in Northern Ireland.

'I wanted to join the PSA because as a thought leader in the regulation of health and social care professionals, it has massive potential to be a positive voice for improvement and change, leading to safer, better outcomes for patients. The opportunity to contribute to those discussions and influence the decisions that are taken is a great privilege'.

#### Nick Simkins – Board Member

Nick Simkins is a Board member and Chair of the Audit and Risk Committee.

He is a Chartered Accountant who has spent his career as a Partner at leading accountancy firms in the UK. He retired in 2022 and has since taken on a number of non-executive roles.

He has worked across the public and private sectors specialising in audit, governance and risk management with leading government, education, charity and not-for-profit organisations.

Nick currently serves as a non-executive director for two housing associations, a further education college and is a Council member of Aston University.



#### Juliet Oliver – Board Member

Juliet Oliver is General Counsel and Executive Director at the Solicitors Regulation Authority.

Juliet specialises in regulatory law and policy. She led the development of the SRA's Standards and Regulations and corporate/governance arrangements. Previously, as a partner at the law firm Fieldfisher, she acted for regulatory bodies across sectors including healthcare and law. At the General Medical Council she advised on the Shipman and Mid Staffordshire public inquiries, and played a leading role in designing its fitness to practise and revalidation procedures.

Juliet is a trustee of the Royal Medical Benevolent Fund. She also has experience sitting as a member of the Professional Standards Committee of the Chartered Institute of Management Accountants, as Chair of the Investigation Committee and Case Examiner at the General Optical Council, on the Audit Committee of the Royal College of General Practitioners and the Law Society's Mental Health and Disability Committee.

### Ruth Ajayi – Associate Board Member

Ruth Ajayi is an Associate Board member.

Ruth holds a degree in New Media Journalism with Media Studies and a Masters in Public Relations. She is also certified in PRINCE2 and Agile Project Management.

Following redundancy from City & Guilds, Ruth utilized her skills within the NHS, managing the delivery of NHS 111 Online in the South West and South East, and overseeing GP Online services implementation across England. She served as Integrated Care Senior Advisor for the East of England before leaving due to a long-term health condition. Ruth chaired the Maternity Services Liaison Committee at Whipps Cross Hospital and is currently a Lay Assessor at the Royal College of Physicians and a Lay Examiner at the Royal College of Obstetricians and Gynaecologists.

Committed to patient-centred care, Ruth is involved in several research programmes and chairs the Advisory Appointment Committee at Barts Health NHS Trust. She cofounded the Disability and Wellbeing Network and the Staff Race Equality Network at NHS England (East of England), highlighting her commitment to Diversity, Equity and Inclusion.

Ruth is pleased to join the PSA Board and is dedicated to ensuring that all citizens confidently access safe and protected healthcare services.



### **Devolved Administration Board Members**

### **Roles and Responsibilities**

- To build and retain public and professional confidence in the regulation of health and social care professionals and to play a key part in the effective and successful governance of the Professional Standards Authority (PSA).
- To support the Chair in setting the strategic direction of the PSA, and monitor and review this on a regular basis in light of developments in the external and internal environments.
- Support the Chair and the Executive Team in developing the PSA in-line with the organisation's strategic aims and statutory duties.
- Lead the work of the PSA by operating effectively at Board level and acting collectively in representing its decisions.
- Provide an independent review, a substantive contribution and constructive challenge at PSA Board meetings and committees.
- Monitor the performance of the PSA's Executive, holding it to account for the delivery of the PSA's business plan and compliance with statutory and other requirements.
- Maintain effective working relationships with the Chair, other Board members, the Chief Executive of the PSA and other senior staff.
- Maintain effective communications with the appointing authority, advising them on the ongoing work on the PSA and reporting to the PSA on their views.
- Working with PSA staff to develop and maintain effective relationships with the Department of Health in the relevant Devolved Administration.
- Working with PSA staff to establish and strengthen key stakeholder relationships within the relevant Devolved Administration.
- Represent the PSA, when required, at official occasions or in dealing with members or the public.
- Demonstrate commitment to the Seven Principles of Public life.



## **Person specification**

Candidates will be expected to demonstrate high standards of corporate and personal conduct including impartiality, integrity and objectivity in the execution of the role and responsibilities. It is essential in your application that you provide evidence and proven examples of your experience against each of the essential criteria below. These responses will be further developed and discussed with those candidates invited for interview, together with the desirable criteria listed.

# We are now recruiting one role from the Devolved Administrations: Wales/Cymru.

### **Essential Criteria:**

- To live and work in Wales/Cymru
- To be able to demonstrate knowledge and understanding of the issues relating to regulation, health and health regulation Wales/Cymru
- Demonstrable ability to operate strategically as an effective member of the Board and contribute positively to the work of the PSA in a non-executive capacity
- Experience of addressing high profile, complex issues and balancing sensitive professional considerations with wider public interest
- Evidence of working constructively and collaboratively with others
- Demonstrable commitment to public service and the protection of patients and the public
- Evidence of a strong team-working approach, the ability to support others, and work effectively with fellow Board members and PSA staff at all levels
- Commitment to Equality, Diversity and Inclusion.

### **Desirable Criteria:**

- A background in professional regulation
- A background in health, social care, and well-developed relevant contacts and personal networks
- Experience of non-executive work, and demonstrable understanding of the boundaries between executive and non-executive responsibilities
- Experience of delivering governance in the public, private or not for profit sector
- Experience of commercial healthcare provision in the High Street (pharmacies, opticians etc)
- Experience of social work and or social care
- Experience of working with or advocating for patients and service users.

# **PLEASE NOTE**: Given our role overseeing the ten statutory regulators and Accredited Registers, applicants are not eligible for this role if they have ever



been registered with any of the ten statutory registers or the Accredited Registers. If they have been an employee of either of the ten statutory regulators or the Accredited Registers this restriction does not apply.

## **Terms and conditions**

### **Time commitment and Remuneration**

Devolved Administration Board Members will be required to commit three to four days per month. The Board meets in person six times a year, with four meetings being in London and two in Scotland, Wales/Cymru or Northern Ireland. Other meetings, including for our committees, usually take place virtually, with the exception of the Audit and Risk Committee which meets in person four times a year in London.

Remuneration is £10,924 per annum. Remuneration is taxable, and subject to National Insurance contributions, both of which will be deducted at source under PAYE before you are paid. Remuneration is not pensionable.

Board Members may claim travel and subsistence expenses, which are properly and necessarily incurred in carrying out your role and responsibilities as a Board Member of the PSA, in line with travel and subsistence policy and rates. A copy of the policy and rates is available on request.

### Tenure of office

The term of appointment is for the maximum term of three years. You may be eligible for re-appointment at the end of your period of office but there is no automatic right to re-appointment.

### Location

You will need to be able to travel to London and other locations for Board meetings, Committee meetings and sometimes for PSA events.

### Accountability

Devolved Administration Board Members are appointed by the Government of the respective Devolved Administration and are accountable to them for carrying out their duties and for their performance. Members will be expected to participate in an annual appraisal process undertaken by the Chair.



# **Eligibility Criteria**

### **Eligibility Criteria**

The Member must live or work wholly or mainly in the United Kingdom.

### **Disqualification for appointment**

You must not be or ever have been a member of a profession which is regulated under the:

Chiropractors Act 1994 Dentists Act 1984 Health and Social Work Professions Order 2001 Nursing and Midwifery Order 2001 Medical Act 1983 Opticians Act 1989 Osteopaths Act 1993 Pharmacy Order 2010 Pharmacy (Northern Ireland) Order 1976 or have been;

- Registered on the Health and Care Professions Council register
- Registered on the Social Work England social worker register

You must not be or have ever been registered with any of the AR's currently accredited by us. If during the period of your appointment to the Board a new register is accredited of which you are or have ever been registered with, you would be expected to step down due to the conflict of interest. You should not have been included by the Independent Safeguarding Authority in a barred list (within the meaning of the Safeguarding Vulnerable Groups Act 2006 or the Safeguarding Vulnerable Groups (Northern Ireland) Order 2007, or by the Scottish Ministers in the children's list or the adults' list (within the meaning of the Protection of Vulnerable Groups (Scotland) Act 2007);

Members of the Councils/Boards of the following organisations are statutorily prohibited from acting as a Member of the PSA's Board unless they relinquish their current office:

- Social Work England
- General Dental Council
- General Medical Council
- General Chiropractic Council
- General Optical Council
- General Osteopathic Council
- General Pharmaceutical Council
- Nursing & Midwifery Council



- Pharmaceutical Society of Northern Ireland
- Health and Care Professions Council

Should a successful candidate hold such a position we would expect them to relinquish the post at the earliest opportunity.

Please note, the PSA also cannot consider Members of Council of organisations that are accredited by the PSA and listed on the PSA Accredited Register, unless the person relinquishes their current office.

Although not a statutory restriction, the PSA will also not consider current employees either of a Statutory Regulatory listed above, or an organisation listed on an Accredited Register.

There are further statutory restrictions regarding convictions, bankruptcy, insolvency which will exclude an individual from being appointed to this role. For full details on this please refer to the Appendix attached.

Applicants, who are shortlisted for interview, must complete a Political Activity and Conflicts of Interest Forms as part of the application process.

Declaration of interests and ensuring public confidence

If you have any business or personal interests that might be relevant to the work of the PSA which might lead to a real or perceived conflict of interest were you to be appointed this should be disclosed. Conflicts may relate to any relevant business interests, positions of PSA or other connections with organisations relevant to the business of the PSA.

If you are aware of any potential conflicts prior to your appointment you should raise these during the process of your application. If an issue arises following your appointment you should ensure that you alert the Privy Council to whom you will be accountable for your performance.

# Appendix

### Additional eligibility criteria

1. It is a condition for the appointment as the chair or a non-executive member that that person—

- (a) lives or works wholly or mainly in the United Kingdom; and
- (b) does not fall within paragraph 2 below
- 2. A person falls within this paragraph if that person-
- (a) has at any time been convicted-

(i) of an offence involving dishonesty or deception in the United Kingdom, or

(ii) of an offence in the United Kingdom, and the final outcome of the proceedings was a sentence of imprisonment or detention (whether suspended or not) of over three months, and the conviction is not a spent conviction;

(b) has at any time been convicted of an offence elsewhere than in the United Kingdom and the appointor is satisfied that the person's membership of the PSA would be liable to undermine public confidence in the PSA;

(c) has at any time —

(i) been adjudged bankrupt or had a sequestration of his estate awarded unless (in either case) that person has been discharged or the bankruptcy order has been annulled,

(ii) been made the subject of a bankruptcy restrictions order or an interim bankruptcy restrictions order under Schedule 4A to the Insolvency Act 1986 or Schedule 2A to the Insolvency (Northern Ireland) Order 1989, unless that order has ceased to have effect or has been annulled, or

(e) has at any time been, or is currently the subject of, any investigation or proceedings concerning the person's professional conduct by any licensing body and the appointor is satisfied that it would not to be appropriate for the person to be a member of the PSA given that investigation or those proceedings;

(f) is subject to-

(i) a disqualification order or disqualification undertaking under the Company Directors Disqualification Act 1986



(ii) a disqualification order under Part II of the Companies (Northern Ireland) Order 1989

(iii) a disqualification order or disqualification undertaking under the Company Directors Disqualification (Northern Ireland) Order 2002

(iv) an order made under section 429(2) of the Insolvency Act 1986 (disabilities on revocation of a county court administration order);

(g) has at any time been removed —

(i) from the office of charity trustee or trustee for a charity by an order made by the Charity Commissioners, the Charity Commission for Northern Ireland or the High Court on the grounds of any misconduct or mismanagement in the administration of the charity—

(aa) for which the person was responsible or to which the person was privy, or

(bb) which the person by their conduct contributed to or facilitated, or

(ii) under -

(aa) section 7 of the Law Reform (Miscellaneous Provisions) (Scotland) Act 1990 (powers of the court of Session to deal with management of charities), or

(bb) section 34(5)(e) of the Charities and Trustees Investment (Scotland) Act 2005 (powers of Court of Session),

from being concerned with the management or control of any body;

(h) has been included by-

(i) the Independent Barring Board in a barred list (within the meaning of the Safeguarding Vulnerable Groups Act 2006 or the Safeguarding Vulnerable Groups (Northern Ireland) Order 2007, or

(ii) the Scottish Ministers in the children's list or the adults' list (within the meaning of the Protection of Vulnerable Groups (Scotland) Act 2007).
